TERMS AND CONDITIONS:

- RENTAL EQUIPMENT. The Customer is hereby interested to subscribe to a rental program (hereinafter referred to as the "Rental") of a KYK Alkaline Water Ionizer and Accessories (hereinafter referred to as "Equipment" and defined in EXHIBIT A) from H2O Life Source (SEA) Pte Ltd (hereinafter referred to as "Company").
- RENTAL TERM. This application is for a rental period defined in EXHIBIT B and is <u>subject to availability</u> of rental stock and the approval of the Company and your Bank. Upon approval you shall receive a confirmed schedule of delivery and installation. Henceforth, the rental program shall begin from the date of installation.
- 3. **PAYMENT TERM**. The payment terms of the Rental are defined in EXHIBIT B.
- 4. CARE AND OPERATION OF EQUIPMENT. During the Rental, the Customer agrees to maintain good repair and operating condition, allowing for reasonable wear and tear. And the Equipment may only be used and operated in a careful and proper manner in accordance to the User Manual provided. The Company shall provide product support during the Rental. Issues relating to utilities supply (water quality and pressure, electrical power) are not within the scope of product support, hence, the Company will not be liable for any lack of performance due to these issues.
- 5. LIABILITY AND INDEMNITY. The Customer agrees to be fully responsible for any loss or damages of the Equipment during Rental. Failure to observe proper care can result in the Company exercising its rights to retrieve the Rental unit or to demand Customer to make full payment at the Replacement Value stated herein. For avoidance of doubts, the definition of damages shall include visible cracks, scratches or dents on the Equipment. The Equipment and any accessories provided shall remain as the property of the Company at all times.

Liability for injury or any other consequence of any persons caused by operating, handling or transporting the Equipment during the Rental is the obligation of the Customer, and the Customer shall indemnify and hold the Company harmless from and against all such liability.

- 6. **DEFAULT**. Failure to comply with any of the herein provisions and requirements is considered a violation of this Rental agreement. The occurrence of any of the following shall constitute default under this Rental and the Company has the right to retrieve the rental equipment immediately:
 - a. The failure to make a required payment under this Rental;
 - b. The insolvency or bankruptcy of the Customer;

c. The subjection of any of Customer's property to any levy, seizure, assignment, application or sale for or by any creditor or government agency.

- 7. ACCEPTANCE OF EQUIPMENT. The Customer shall inspect the Equipment delivered pursuant to this Rental. The Customer shall immediately notify the Company of any discrepancies between the Equipment & Accessories Schedule, defined in EXHIBIT A and the actual items received on the day of delivery & installation.
- 8. **ABSOLUTE DISCRETION.** The Customer agrees that the Company shall have the absolute discretion to grant or not to grant the Rental application, or to pre-maturely terminate the Rental with 7-day notice.

- 1. **PAYMENT**: Payment may be made in full or quarterly in advance.
 - a. A <u>security deposit of \$500</u> (brand new system) is payable upon application. This security deposit is NOT meant to cover any rental payment due for the period. However, it may be used to repair damage(s) to the unit other than "ordinary wear and tear" (wear and tear that ordinarily occurs with the use of any unit) and to have the unit cleaned at a cost of \$50, if the unit was not left as clean as when it was rented. Hence, Security Deposit less any necessary charges as defined herein, becomes refundable at the end of the Rental when the Rental unit is returned in good rentable working condition and the Rental period of 12 months is completely fulfilled with no outstanding rental due.
 - b. Customers who have opted for a <u>single full settlement with cash / cheque / NETS upfront</u> can enjoy \$50 cash rebate when making the payment. This amounts to a total of twelve (12) monthly Rental fee of \$174.92/Month (i.e. \$2,099.04 less \$50) and this is payable upfront upon application. Price includes 7% GST.
 - c. The first payment of \$524.76 is an advance payment for the first 3 months of use, payable upon confirmation.
